## A DAY WITH THE JUDGES CLINIC

MAT Tumbling/Trampoline will have three to four judges brought into our gym to judge your tumblers/trampolinists in all levels. Coaches and parents will be able to sit with and speak to the judges before, during, and after their child's/athlete's pass. This is great opportunity for parents, coaches and athletes to actually hear and understand what the judges are taking deductions for. Ask questions while it is still fresh in your mind. Coaches, even if you wish not to attend please provide your families with this information and the opportunity to better themselves as athletes and parents.

This clinic is for any athlete at the sub-beginner thru advanced level in any event. We had a great turnout last year for this clinic and we look forward to offering out all three events again, tumbling, trampoline and double mini trampoline. For this clinic we will be able to utilize as needed Two Euro double mini trampolines, One Euro in ground trampoline, 60' tumble trak with trampoline landing system and Three 84' foot rod floors. One rod floor goes into a 10 X 14 foam block pit.

**This will be an excellent learning experience for coaches, judges, and athletes. We will make this not only a day for learning, but MAT Tumbling/Trampoline will also provide pizza, drinks and fun for all participants.**
